# PAH and the body

PAH symptoms happen when the blood vessels inside your lungs become narrow, making it harder for blood to flow. This can be caused by imbalances of certain natural substances in your body: endothelin, nitric oxide, activin, and prostacyclin.



# Oral prostacyclin provides another approach to treating PAH

**Orenitram helps to replace the natural prostacyclin you may be missing.** It's formulated to help keep the blood vessels in the lungs open, which makes it easier for your heart to pump blood through your lungs.



# Is your current PAH therapy falling short of your treatment goals?

Orenitram targets a different pathway from other oral medicines you may be taking for PAH. That's why adding it to your treatment plan may be the next step to help you do more to control your PAH.

# **Meet Orenitram**

Orenitram is a prescription medicine used to treat PAH.

It helps slow down the progression of your disease and improve your ability to exercise.

• About all the medicines you take, including prescription and over-the-counter medicines, vitamins, and herbal supplements. Orenitram and other medicines may affect each other causing side effects. Do not start any new medicine until you check with your healthcare provider. Especially tell your healthcare provider if you take another medicine that contains treprostinil, such as Remodulin® or Tyvaso®.



# Why Orenitram?

Orenitram may help you reach your treatment goals and control your PAH. It has been proven to delay the progression of PAH and may help improve PAH symptoms. Many people feel results in as few as 3 months.\*

#### How should I take Orenitram?

- Do not change your dose or suddenly stop taking Orenitram without first talking to your healthcare provider.
- Orenitram is usually taken 3 times a day (about every 8 hours) or 2 times a day (about every 12 hours). Your healthcare provider will tell you how often you should take Orenitram. If you have side effects, your healthcare provider may tell you to change your dose or when you take Orenitram. Take Orenitram with food.

<sup>\*</sup>In a clinical study that included 690 patients who were all taking a single oral PAH medicine (PDE-5i, sGCS, or ERA). At the beginning of the study, these patients added either Orenitram or placebo.

#### How should I take Orenitram?

- Swallow Orenitram tablets whole. Do not split, chew, crush, or break your Orenitram tablets. Do not take Orenitram tablets that are damaged or broken. If Orenitram tablets are not taken whole, they may release too much medicine at one time. This can lead to side effects.
- If you miss your dose of Orenitram, take the missed dose as soon as possible with food.
- If you miss 2 or more doses of Orenitram, call your healthcare provider to see if you need to change your dose.

# What is titration?

When you start Orenitram, your healthcare team will work with you to gradually increase your dose—a process called titration.

During this time, your body is still getting used to the medicine, and you will likely experience side effects. Remember that side effects may get better with time as you continue increasing your dose of Orenitram.

# Why is titration important?

## Titration is all about finding the most effective dose for you.

That's why it's important to stay committed to your treatment. You may not get the most benefit from Orenitram until you reach your target dose.

#### How should I take Orenitram?

- If you take too much Orenitram, call your healthcare provider or go to the nearest hospital emergency room right away.
- You may see the tablet shell in your stools (bowel movements).
   This is usually normal. The tablet shell is not digested. If you have diverticulosis, the tablet shell may get stuck in a blind pouch or diverticulum in your intestine.

# **Personalized dosing**

Since PAH is a progressive disease, your treatment needs may change over time. Your healthcare provider can continue to increase or change your dose to meet your needs. That way, you may be able to stay with Orenitram for the long term to help control your PAH.\*

# **Taking Orenitram**

Like other medicines you may be taking, Orenitram is an oral tablet. You take it with food, usually 3 times daily (every 8 hours).\* Talk to your healthcare team about food choices that may work best for you.



6 am breakfast • 2 pm afternoon snack • 10 pm bedtime snack

# Tips for staying on track



Taking Orenitram with food helps the body absorb the medicine and may help reduce side effects.

But you don't have to take it with a full meal—a snack is fine



To avoid missing a dose, try adding alerts to your calendar or smart phone alarm



If you've started on Orenitram and you miss a dose, take the dose as soon as possible with food. If you miss 2 or more doses, call your healthcare provider for guidance

# **Expected side effects**

The most common side effects of Orenitram include headache, diarrhea, nausea, vomiting, flushing, and pain in the arms, legs, and jaw.

- Side effects are a normal part of taking Orenitram, especially at first
- They may get better with time as you continue increasing your dose of Orenitram
- Taking Orenitram at the same time you eat or
   15 minutes after may help minimize side effects

# It pays to be proactive

Side effects are a reality—but that's not the whole story. Write down your experience. Talk to your doctor. And know that feeling better is possible if you stick with it.

# **Managing side effects**

The more you communicate with your healthcare team about side effects, the better. That way, they can suggest some ways to help:



#### **Headaches**

Over-the-counter treatments such as acetaminophen or ibuprofen



## Nausea & vomiting

Various anti-nausea and anti-vomiting medications



#### Diarrhea

Adding fiber to your diet or taking anti-diarrhea medication
